The V.A.T increase, the petrol price increases and the sad state of our economy have left Telkom employees in a precarious position financially. To make matters worse the company offered us a paltry 3% increase based on the 50th percentile of our functional grade! This from the ONLY State-owned Enterprise that showed a profit for the previous financial year. All the other SOC's offered their employees an increase at least equal to inflation.

Some interesting comments extracted from an article on Fin24:

"South Africa's take-home pay levels declined dramatically in May — and are expected to remain under pressure until July when adjustments to public sector wages are taken into account."

"The take-home pay data suggests employees have to carry the burden of a shrinking economy."

"The decline leaves take-home pay in constant terms at the same level as in December 2013"

The time has come for us to decide: Are we going to accept the pittance that we have been offered and happily carry on working our fingers to the bone while becoming poorer, or are we going to stand up and fight?
